1. Rental Bond Number

The Rental Bond Number must be shown on this form. Failure to show this number may result in unnecessary delay in the processing of change of shared tenancy arrangement details.

2. Previous Tenants

This section MUST be signed by all of the tenants currently registered with Renting Services.

3. New Tenant/s

This section MUST be signed by all of the remaining and new tenants now to be registered for this bond.

4. Landlord/Managing Agent

The current landlord or managing agent MUST approve the change of shared tenancy arrangement by signing in this section.

5. Disclosure of Information

Information provided on this form may be disclosed to lawfully authorised government agencies upon demand.

Important Information

- Outgoing tenants DO NOT sign this form until you have received your money from the other tenant/s.
- At least one of the original tenants must continue in occupation.
- This form cannot be used if the Department of Housing contributed to the original bond.
- This form is not a substitute for a new Residential Tenancy Agreement.
- Delays in notifying Renting Services of changes in tenancy details can cause inconvenience when claiming refunds of rental bonds.
